# WELCOME

Adjacent to Maui's most beautiful beach sits the Wailea Beach Resort, the site of the Federation's 2018 Annual meeting. Overlooking the resort is the long dormant volcano, Haleakala, while visible in the distance is the Molokini Crater, and the Islands of Lanai and Kaho'olawe, Hawaii. The kids will have no problem keeping up with the adults given all of the fun activities available on the Wailea Beach Resort property. The Nalu Adventure pool has the highest and longest water slide on the island, splash zones for the younger kids, and the Mo Bettah Food Truck serves delicious Pupus, shaved ice, and tacos nearby. After time on the beach or by the pool, the Aloha kids club and game room is the perfect hangout. Maui's only "Escape Room"— a new form of adventure entertainment— is also on site at the Wailea Beach Resort.

During the week, families can surf, play in the family golf tournament, snorkel, and paddle on the waters offshore Wailea Beach. Or you can have your pick of one of the six swimming pools on the 22-acre property. Kids and adults alike can learn to play the ukulele, make leis and shell bracelets, practice yoga on the beach, or take a class—both cooking and photography are offered.



The meeting will officially start on Sunday, July 29th with the F&B, Admissions and Sites Committee meetings starting at 7:00 a.m. (10:00 a.m. Pacific Daylight), followed by the meeting of the Board of Directors from 8:30 a.m. to 2:30 p.m. Immediately thereafter, the Projects and Objectives (P&O) committee, Membership, Development and Recruitment (MDR) committee, and Foundation Board will meet from 2:30 p.m. to 4:00 p.m.

Be ready to be inspired by our program, which kicks off on Sunday with a message of inspiration, faith, courage, and perseverance by Body and Soul author, Bethany Hamilton, who lost her left arm to a tiger shark while surfing at the age of 13. After nearly losing her life, quitting was not an option. Two years

later, Ms. Hamilton won the National Women's Surfing championship and has since become a New York Times Best Selling Author, the subject of the film Soul Surfer (based on her book), a mother, and a contestant in the Amazing Race—placing third with her husband Adam Dirks! Bethany's latest project, UNSTOPPABLE, a surf documentary which will showcase her as one of the best surfers in the world, is set to release in the Summer of 2018. Bethany is the perfect opening keynote for our Maui program—The Whole Lawyer: Bringing Health, Passion and Purpose to our Profession.



Before our Sunday dine-around, we launch our social activities on the rooftop of the Wailea Beach Resort with the Mai Tais and Muumuus cocktail reception at sunset. Break out your best Aloha attire and set the tone for a great week!

On Monday, we celebrate the spirit of Aloha and our friendships with Fellowship Day, during which members can select from a rich and varied array of activities that will make you wish you had two or three such days.

Check out the Schedule of Activities and Program Schedule on the pages that follow. FDCC room rates are available through June 28, 2018, but we encourage you to reserve your rooms today. Check-in is at 4:00 p.m. Check-out is at 12:00 noon. In the event your flights arrive early or depart later, the hotel can check your luggage at the bell stand.

Book online, anytime or call the Wailea Beach Resort at 808.879.1922 and mention FDCC to receive the group rate. FDCC single or double room rates are available three days pre and post our official meeting dates:

A resort fee of \$10 per evening and 14.42 % room tax applies. The resort fee covers wireless internet, in-room; 30 minute photo session with 5 x 7 souvenir photo, bike rental, shell lei greeting, 2 bottled waters daily, 2 mai tai's from Kapa Bar & Grill or 2 Starbuck's Coffee, daily fitness classes and daily Hawaiian cultural activities.

#### THE WAILEA BEACH RESORT

From the adults-only Maluhia Serenity pool, the Nalu Adventure pool, or the 'Ohi oceanfront pools, there is a swimming pool for everyone. Try one each day if you like. Maui's newest great restaurant is Humble Market Kitchin, founded by the Island's legendary Chef, Roy Yamaguchi. Humble Kitchin is located off the lobby with spectacular views of the Pacific Ocean. This farmto-table restaurant uses only the finest and freshest market ingredients.

KAPA Pool Bar + Grill is a poolside bistro featuring locally sourced products set against the backdrop of Wailea Beach Resort's stunning duo of resort pools and oceanfront cabanas. The restaurant's name is in homage to the ancient tradition of kapa, a Polynesian fabric design technique with distinct Hawaiian influences and historical significance.

#### ALOHA FDCC KIDS

Evening programs for children 5-17 will be offered on Tuesday, July 31, 5:30 p.m. – 9:00 p.m. and Friday, August 3, 5:30 p.m. – 10:30 p.m. The programs will include dinner and activities.

Due to strict Hawaiian laws, we are unable to provide child care during the morning meetings. However, we have arranged for licensed professionals to be available for hire directly through the hotel.

#### GETTING TO MAUI AND THE WAILEA BEACH RESORT

Direct flights to Maui (OGG) are plentiful, or you can connect through Honolulu (HNL.) The airport in Kahului (OGG) is 17 miles, or about 30 minutes from the Wailea Beach Resort. Reserve your rental car, take an UBER or hire a car or taxi to take you to the Wailea Beach Resort. Resort.

#### DRIVING ON MAUI

When driving on Maui, be ready to chill. Turn on the sweet sounds of Hawaiian music and be mellow because the fastest speed limit is 45-mile per hour. There is zero tolerance for drinking and driving on the Island so don't do it.

#### HULA GIRL CHARM

The 2018 Annual Meeting charm is a depiction of the Hula dancer, an art form developed on the Hawaiian Islands which is accompanied either by music or chant. The Hula is an important and beautiful dance that will be a prominent part of the Thursday Luau. The dance is a form of storytelling communicated by gestures of the hand, hip and feet.

#### HAWAIIAN TIME DIFFERENCE

Unlike the mainland, Hawaii time remains constant year-round, meaning that during the summer months Hawaii is three hours behind Pacific Daylight Savings time and six hours behind Eastern Daylight Savings time. So those early morning meetings aren't really that early after all-but beware of those late nights!

#### ARTIST CURTIS WILSON COST

Curtis Wilson Cost is the quintessential Maui landscape artist, with over 500 original oil paintings to his credit spanning over a period of nearly forty-five years. He operates the Cost Gallery with his wife, Jill, from the Kula Lodge located at 15200 Haleakala Hwy, Kula, HI on the road up Haleakala. For our convention gift, families will choose from three beautiful matted prints hand-selected for the Federation by Mr. Cost himself including ocean and Maui Upcountry scenes. #### HAWAIIAN DRESS CODE—RESORT ATTIRE

Men need not dress in a suit or even bring a sport coat, but this is the FDCC after all and collared shirts and slacks are always a nice touch. At most of our functions, men can wear: Aloha or polo shirts; khakis, linen slacks or dress shorts; and loafers or boat shoes. Women are


#### **BOOK CLUB**

## The Three-Year Swim Club: The Untold Story of Maui's Sugar Ditch Kids and Their Quest for Olympic Glory

Written by Julie Checkoway, this New York Times' Best Seller chronicles the most unlikely story of a school teacher, Soichi Sakamoto, who in 1937 challenged the impoverished children of workers on Maui's sugar plant to train with him for three years. They signed contracts and agreed never to be late, to train with their coach and teammates, and to never miss a practice. Their goal? To qualify for the 1940 Tokyo Olympic Games. One problem: Coach didn't know how to swim himself. Most of the children were Japanese-Americans, barefoot, and learned to swim in

the muddy irrigation ditches near the sugar plant where their parents worked and lived. Unlike elite athletes competing on the world stage in that era, TYSC team members trained several times a day and for hours on end. The Three-Year Swim Club is a perfect book for those who enjoy sports, history, and root for the underdog. Expect a vibrant discussion led by Mary Alice Collins on Wednesday, August 1, at 10:00 a.m.





## **MAUI FUN FACTS**

Hawaii officially joined the United States as the 50th state on August 21, 1959, and consists of eight main islands that were united under the rule of King Kamehameha. Maui's nickname is the Valley Isle and enjoys a total population at last count in 2010 of 144,444.

At the time of the Japanese attack on Pearl Harbor, Hawaii was a U.S. territory. President Franklin Roosevelt called December 7, 1941, "a date which will live in infamy." On that day, Japanese planes attacked the United States Naval Base at Pearl Harbor, Hawaii Territory. The bombing killed more than 2,300 Americans.

Hawaii is also the quarterback state, with Oregon's Marcus Mariota winning the Heisman Trophy in 2014 and Alabama's Tuâ Tagovaiola throwing the game winning touchdown in the 2018 National Championship game. Both players attended St. Louis High School in Honolulu.

The famous road to Hana is 64.4 miles long, includes 59 bridges of which 46 are one lane, and takes nearly 3 hours to drive each way.

Maui Jim's sunglasses is headquartered in Lahaina. You can even bring your broken or worn MJ sunglasses and have them fixed or new lenses installed.

## HAWAIIAN LINGO

"Aloha" means hello and good-bye, but is more than a word of greeting or farewell or a salutation. "Aloha" also means a mutual regard and affection and extends warmth in caring with no obligation in return. "Aloha" is the essence of relationships in which each person is important to every other person for collective existence. "Aloha" means to hear what is not said, to see what cannot be seen and to know the unknowable.

"Aloha au ia 'oe" means "I love you."

"Ohana" means "family."

"Big Kahuna" means "Scott Kreamer."

"Mahalo" means "thank you."

**"Muumuu"** is a loose dress of Hawaiian origin that hangs from the shoulder and are often brilliantly colored with floral patterns. They are the preferred Hawaiian dress for weddings and formal occasions.

"Pupu" is a Hawaiian appetizer.

## **SCHEDULE OF ACTIVITIES**

### FELLOWSHIP DAY

#### MONDAY, JULY 30, 2018

#### PEARL HARBOR

4:30 a.m. - 7:00 p.m.

December 7, 1941 is a day of infamy on which over 2400 men and women were killed during Imperial Japan's surprise attack on Pearl Harbor, leading the U.S. into World War II. You will be educated and moved on a day trip you will never forget. While at Pearl Harbor you will have time to walk through the Museums with your individual audio guide followed by a private tour of the USS Missouri, where your private docent will provide highlights from the beginning to the end of World War II. (December 7, 1941 to September 2, 1945.) The USS Missouri was the location of the signing of the Document of Surrender by the Japanese Empire. You will also tour the USS Arizona Museum and take a boat ride to the sacred USS Arizona Memorial, where nearly 1000 sailors remain entombed to this day. We will also tour the Pacific Aviation Museum and the hangars housing authentic aircraft involved in the battle as well as modern jet fighters. The tour also includes the USS Bowfin Submarine Museum. The activity includes all round-trip transportation by bus



and air, transfers, tickets, and an Island style lunch at the Restaurant 604 before returning back Maui! Total cost is \$519.50 per adult and \$499.50 per child, 3-11 years old. This tour is limited to the first 50 registrants and is sure to sell out quickly. Expect to return to the hotel by around 7:00 p.m.

#### **PI'IHOLO CANYON ZIP LINE**

8:15 a.m. - 2:15 p.m.

Voted the "Best Land Activity on Maui," the Pi'iholo Canyon Zip line offers two thrilling courses that provide speed, exhilaration, and world class views of the lush Island forests. The five-line course has side-by-side lines (think racing for our competitive types) and concludes with both a <sup>1</sup>/<sub>4</sub> mile line, followed by a <sup>1</sup>/<sub>2</sub> mile line offering a birds-view over the Canyon! Minimum weight for this course is 75lbs, max is 275 lbs. The seven-line Tree-Top course is ideal for kids eight and up who are not quite heavy enough for the five-line course. The minimum weight for the seven-line is 50 lbs.; the max is 250. Minimum age is 8 for both tours. You will walk over suspension bridges, up footbridges, and down ladders on this activity so closed toe shoes and good balance are a must. Select which course you prefer on the registration form and be prepared for a day of FUN in the sun. Cost of the 5-line course is \$205 and the 7-line course is \$185.

#### MOLOKINI SNORKELING ON THE KAI KANANI I AND II

5:15 a.m. - 10:15 a.m. or 9:15 a.m. - 1:45 p.m. Visible in the distance from the Wailea Beach Resort is the small crescent shaped volcano crater Molokini, which is a protected bird sanctuary offering world class snorkeling in crystal clear waters. Snorkelers will witness all varieties of fish, sea urchins, and possibly rays, white tipped shark and octopus. Unlike other tours, the Kai Kanani Catamaran launches from nearby Makena beach, ten minutes from the Wailea Beach Resort, which is closer to Molokini than the by at least 20 minutes. Expect to experience a spectacular sunrise, snorkeling during the calmest part of the day, and conclude the trip by swimming with the turtles closer to shore. A later departure time is also available for those who want to sleep in. Masks, fins, floats, sunscreen and everything you need other than towels are provided by a fun, energetic and educational staff. GoPro cameras are available to rent. Breakfast or lunch and cocktails are also served when snorkeling has concluded. You will load and unload from the water with the assistance of the Kai Kanani staff. Each family will receive a copy of "Masks, Fins and Snorkel, The Adventure Guide to Maui's Best Snorkeling," by Rich Schieber. Hotel departure for Sunrise Deluxe Snorkel is

## "Here Today, Gone To Maui: The New York Burlington Insurance Case Has Upended the Insurance and Construction World"

The recent New York State Court of Appeals case *Burlington Insurance v. The New York City Transit Authority* held that for there to be insurance coverage under the additional insured endorsement there must be more than a simple causal link between the acts of the named insured and the plaintiff's accident. "Proximate cause" must be established before an additional insured is entitled to coverage under this endorsement. (ISO CG20 10 07 04).

The decision will affect how construction contracts are drafted, especially indemnification provisions; what additional insured endorsements are appropriate; how Insurance Companies will treat tenders under this endorsement. We will look at the endorsement from both the Owner/GC/CM and the Subcontractor's perspective.



#### MAUI OCEAN CENTER

The Maui Ocean Center is one of the largest collections of live Pacific corals in the world, and includes 20 daily presentations by marine naturalists, outdoor tide pools, and a 750,000-gallon Open Ocean Exhibit with a 240-degree view acrylic tunnel. 
#### SURFING GOAT DAIRY
