



#### Preparing for PDPM: Do You Have the Data Necessary to Survive?

There have been two fundamental shifts in health care reimbursement over the past five decades. The adoption of the DRG system in the early 80s and the introduction of PPS in the 90s. Both of these dwindled the overall number of providers. While it was not the government's intent to put providers out of business, many operators were unable to adapt to the new model and were forced to close their doors. The pending change from a RUG-based model to the Patient-Driven Payment Model (PDPM) will constitute the third and possibly the most disruptive change in payment reform. The real impact of this new model will be about payment accuracy. As we know, most MDS coordinators are not certified coders, and SNFs do not generally employ coders. Understanding the proper ICD-10 will be critical. Get it wrong, and your payment could be too low and the SNF may not get its costs covered. By deploying an evidence-based practice, you can avoid overutilization or underutilization. While it may be tempting to seek out more complex patients, maintaining a proper patient mix will be critical. Gordon, my service dog, is a mobility support animal who assists me with balance, walking and momentum. I have lupus and experience bouts of dizziness, extreme fatigue and occasional falls. When I brought Gordon home in March of 2015, I became "The Service Dog Information Desk." At the time, I was the director of staff training for a large IDD services agency, and many case managers reached out to me to ask the questions that the families they supported were asking them about service dogs. Coworkers asked similar questions because people in their families were considering getting a service dog. Strangers stopped me in stores and in airports asking who trained him, how long did it take, do I think that Gordon could do this thing or that thing? I didn't mind all the questions. The people who trained Gordon had prepared me to be an ambassador of sorts. In fact, it helped me realize how much I had learned during the application, training and acclimation process with Gordon. But I got so many of the same questions over and over that I decided to create a training session. The information in this session can easily be adapted if you're supporting adults who live independently rather than families. Anyone considering a service dog should be guided through this process.

The workshop also includes a thorough overview of the symptoms of schizophrenia, as well as information on the challenges of treating individuals with schizophrenia. Special attention is paid to dual diagnosis of intellectual and developmental disabilities and mental illness.

#### Pain Management: Improving Pain Programming in Our Long Term Care Communities

A comprehensive, collaborative approach to decreasing pain and opioid use with our long term care residents is the key to improving quality measures and their quality of life. #### Reducing Medication Errors During Transition of Care from the Hospital to the SNF

As part of a performance improvement project, Burgess Square Healthcare and Rehab Centre (BSHRC) conducted a pilot study in conjunction with a consultant pharmacist to reduce medication errors throughout the continuum of care for post-acute patients. Based on this pilot study, many opportunities for improvement were identified both on the hospital side and the SNF side. Based on these findings, BSHRC began partnering with local hospitals and practitioners to facilitate changes in processes to help reduce instances of these common errors. In addition, BSHRC engaged in cycles of evaluation and improvement to improve internal processes to reduce medication errors. Through these cycles of evaluation and improvement, BSHRC has been able to tie this PIP into other PIPs including fall prevention, reduction of re-hospitalization and improved regulatory compliance. During this session, we will present our pilot study, our findings, how we instituted processes within the facility and worked with local partners to improve processes and what facilities can do in the future to facilitate their own process improvements to reduce medication errors.

#### Addressing Distress Through Meaningful Activities for Residents with Dementia

This program became the culture of Aviston Countryside Manor and grew into an Elder Shadowing program that requires all newly hired staff to live with a resident for 24 hours before they are able to begin their new job.

Individuals with IDD have a very similar life span to the general population but the risk for frailty is compounded by secondary conditions that may have developed related to a lack of physical activity. The population with IDD has a considerable variability in function and fitness needs. Individuals range in age from 18 to late 80s. Individuals with Down's syndrome, cerebral palsy and neuromuscular disease have had an even more limited exposure to exercise and physical activity and have an increased risk for injury related to secondary conditions. The BEST Fit program was established to address these needs.


